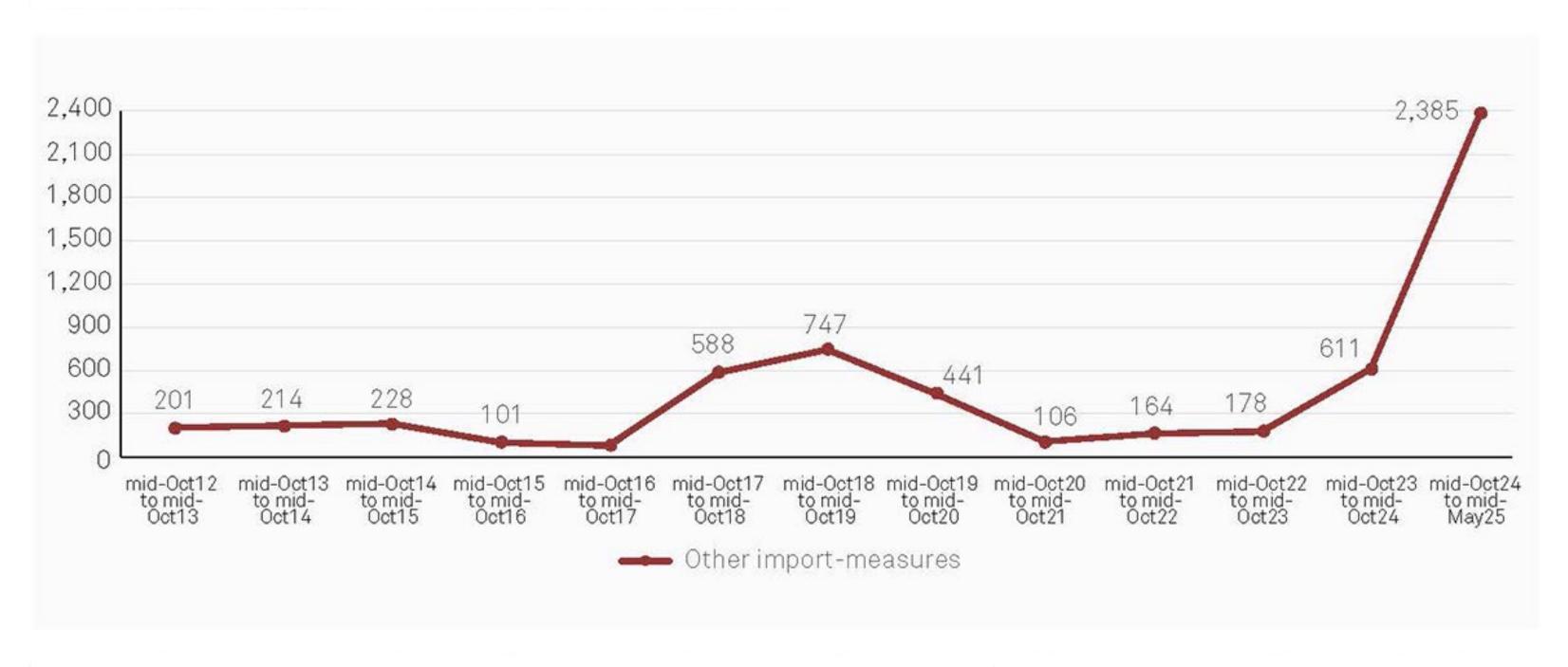




TARIFF IMPLICATIONS

Trade coverage of new other trade and trade-related measures affecting imports by reporting period (not cumulative) in USD billion



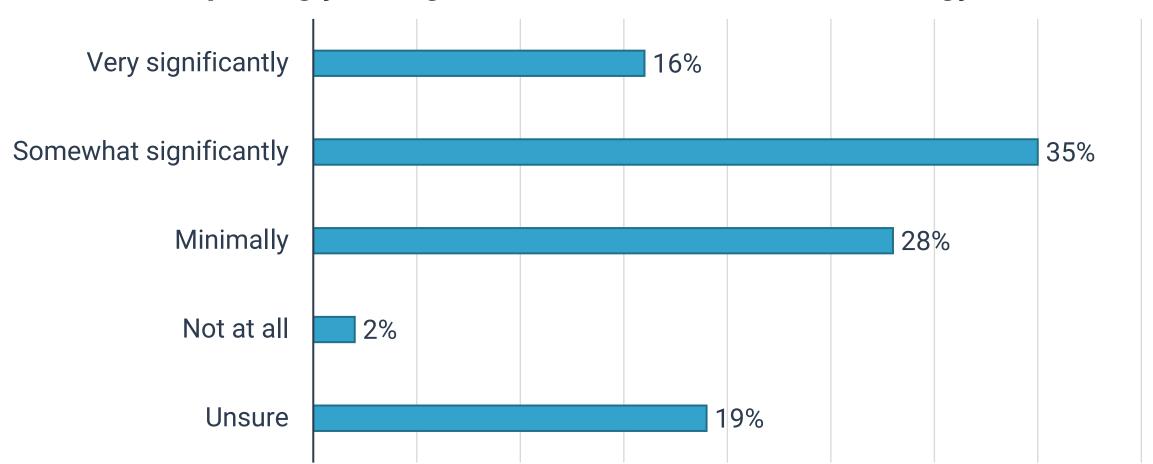

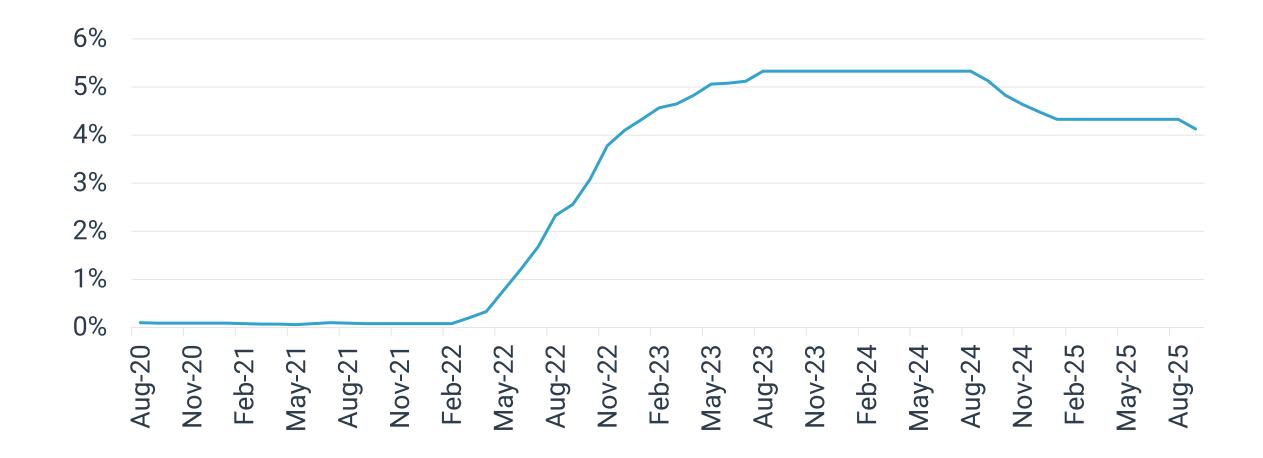

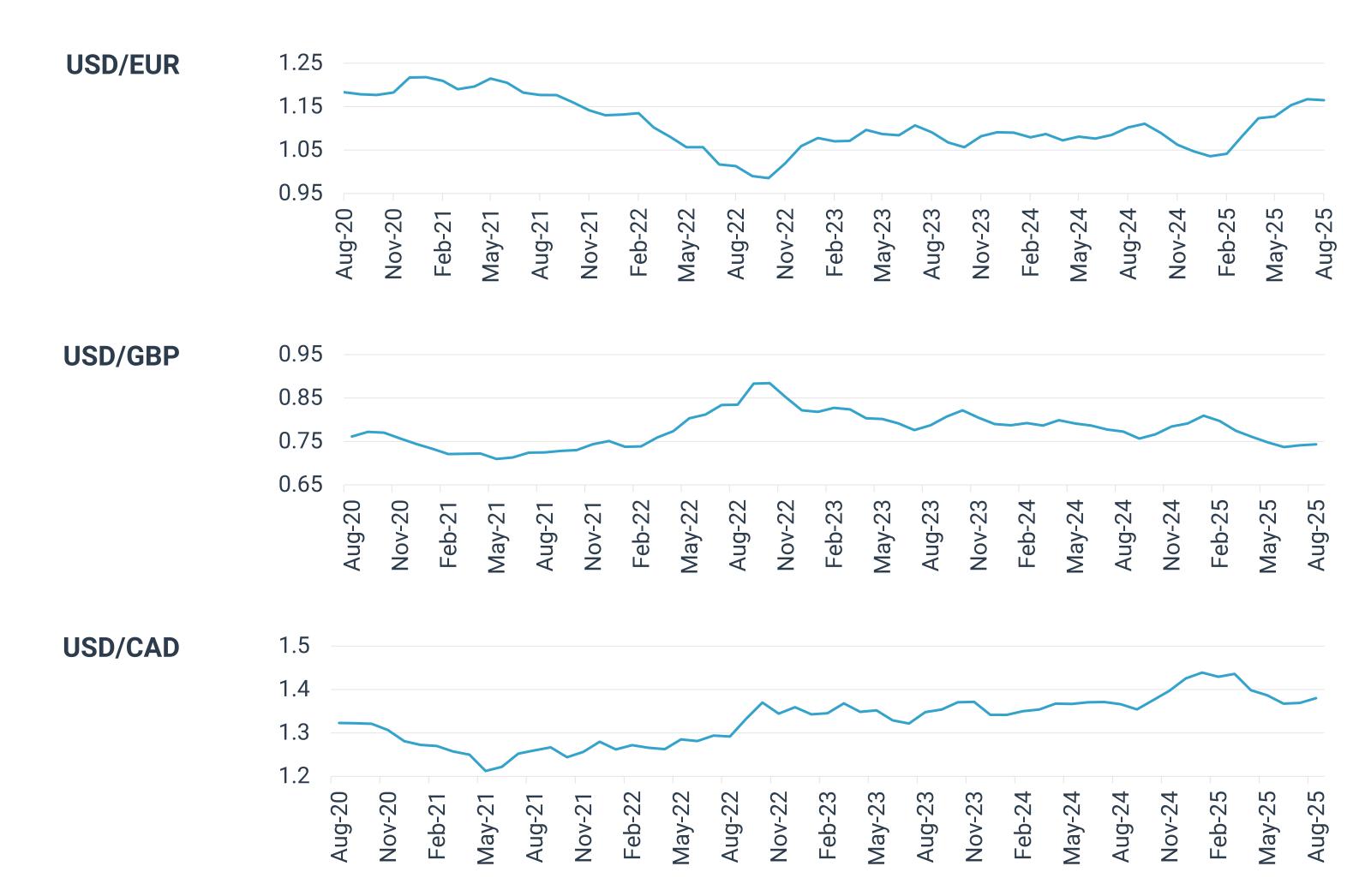

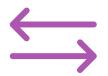

HANDLING INVENTORY

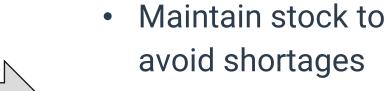
SHIFTING APPROACHES

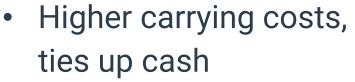


JUST IN TIME

- Minimal inventory, ordered as needed
- Lower storage and holding costs
- Requires reliable suppliers and logistics

JUST IN CASE

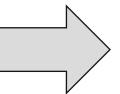




 Protects against supply chain disruptions

JUST BEFORE (TARIFFS)

- Purchase shortly before demand spikes
- Hedge against rising tariff costs
- Balances inventory risk and cash flow

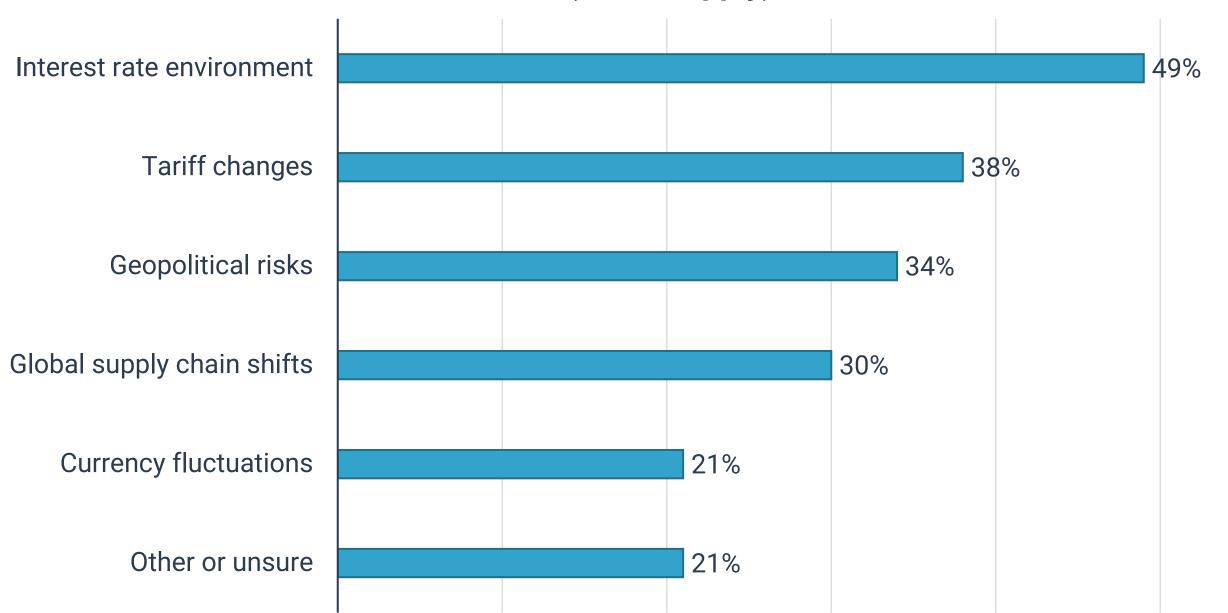

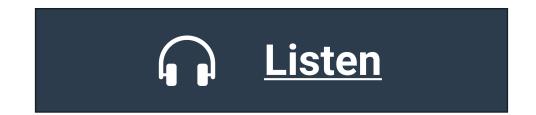
